The FY22-23 workers compensation premium estimate is \$512,570. The significant increase is due to the presumptive cancer laws for public safety workers and COVID claims. Securis has asked the governor's office to be considered for a portion of the CARES Act monies the

state has received as fire districts did not directly receive CARES Act money because they are not a town or city.
