Board member VanderNaalt inquired whether Arizona Fire and Medical Authority will be willing to participate in a study done by one of these agencies. Chief Schmitz stated that he felt AFMA would participate in the study as they are interested in having a study done between their authority and our district. The board members asked Chief Schmitz to follow up with the companies who

submitted a proposal to see if they would be able to make a presentation via Zoom at next Tuesday's (June 28th) regular board meeting. They also asked that he present the following questions to them in advance of the presentations:

- 1. Have these companies done work with fire districts prior as there is a big difference between fire district and fire departments?
- 2. What level of detail is provided in the study report and what areas are covered?
- 3. Is there a cost assessed for providing a presentation to the district?
- 4. Is each company compliant with Arizona statutes and can they legally work in Arizona?
- 5. Can we use the data from this feasibility study for future studies?
- 6. As to travel costs, can a more detailed accounting of what is covered in the proposal amount be provided?
- 7. A list of any potential costs that might not be covered in the proposal, if any.
