<u>BUSINESS CONDUCTED:</u> The Committees of the Board discussed various matters within their areas of responsibility.

I. Legal and Insurance

A. The district currently contracts for fire chief services through an intergovernmental agreement with Buckeye Valley Fire District (BVFD). Chief Burdick is the fire chief of BVFD and is currently the Sun City Fire District's fire chief (SCFD) by means of the intergovernmental contract in place. Chief Burdick presented a draft of a new contract between the Arizona Fire & Medical Authority (AFMA) and SCFD for fire chief services that would be effective May 15, 2022, when Chief Burdick terminates as the BVFD fire chief and assumes the position of the AFMA fire chief. The current contract with BVFD would no longer be in effect as of May 15th when Chief Burdick is no longer employed by BVFD. The draft contract is for same amount (\$55,000) as the current contract with BVFD. The draft contract would be effective May 15, 2022, through June 30, 2023. It was noted that the contracted fees go to the entity (currently BVFD) and not as payment to Chief Burdick. The board has asked for a few revisions, time to review the document, and that SCFD's attorney also review the document. USCFFA members presented results from a recent member survey that show 90% of those who responded to the survey were in favor of keeping Chief Burdick as the contracted fire chief. This item will be placed on a future agenda for consideration.
