<u>BUSINESS TO BE CONDUCTED:</u> The Committees of the Board will discuss various matters within their areas of responsibility.

- I. Legal and Insurance
  - A. Action Item Shared Fire Chief contract (Presenter: Assistant Fire Chief Rob Schmitz)
    - 1) The action item for Shared Fire Chief contract was presented to the board for approval. The motion passed with 4 in favor and 1 opposed to the Shared Fire Chief contract. (M: Phil LaBarbera/2<sup>nd</sup>: David VanderNaalt)
  - B. Discussion Item Brycer contract (Presenter: Fire Marshal Jim Fox)
    - The board members were presented with the Brycer contract document. Fire Marshal Jim Fox gave an account of the code compliance tracking system process in addition to an overview of the Brycer Company's services, contract, costs, and revenue refunds to the Fire District. Assistant Fire Marshal Kenney Kovac gave an overview of the capabilities provided by the tracking system in assisting with inspection compliance. This item will be proposed to the board for approval at the board meeting on March 23<sup>rd</sup>.
  - C. Discussion Item Shared manpower agreement with Buckeye Valley Fire District (Presenter: Assistant Fire Chief Rob Schmitz)

The Buckeye Valley Fire District Shared manpower agreement was presented to the board for consideration/discussion. Assistant Fire Chief Rob Schmitz addressed questions from board members concerning the agreement. This item will be put forth to the board on March 23<sup>rd</sup> for approval.

  - 1) Board Clerk Tim Wilmes presented an update on the Pension Funding matters. There was an overview of the stimulus package, obligation bonds, pension, liabilities in addition to an overview of Tier 3-, and 20-year payoff.

- A. Discussion Adding a Plymovent system to Fire Station 133 (Presenter: Assistant Fire Chief Rob Schmitz)

Board member Steve Arnold called-for "additional supplemental charges" on proposal to be removed. This item will be proposed as an action item at the March 23<sup>rd</sup> board meeting for approval.
