1. The report for fire department operations was given for December 2021, which included an overview of the incident counts, types, and response times.

D. Emergency Medical Services / Ambulance Operations

- 1. The ambulance operations report was presented for the month of December 2021. The report included the incident counts, types, and transports.
- Chief Schmitz reported that Drew Holzer and Anne Giamundo passed their National Registry exam and are working in the field. Taylor Marquez and Matt Schall have begun the Phoenix Fire Department paramedic program. They are scheduled to graduate in October 2022.

F. Resource Management

- 1. Chief Schmitz reported that Izacc Ramos, our new mechanic, has completed the EVT class for his F5 aerial ladder apparatus certification. He has taken the exam and will get the results in a few weeks. Additionally, the annual hose and ground ladder testing was completed on December 17th & 18th by Fire Catt. There was 19,800 feet of hose tested, of which 1,075 feet failed. This represents a fail rate of 5.43%, which is within Fire Catt's typical fire year failure rate range of 3 7 %. There was 387 feet of ground ladders tested with zero failures.
- Chief Schmitz reported that the Bay 9 gym conversion is coming along. Additionally, the Plymovent equipment installation at FS133 has been completed. Equipment to upgrade FS131 & FS132 has been ordered but there is no installation date yet.

G. Administrative/Special Projects

 There was no action on the appointment of a lay member to the Sun City Fire Fighter Relief and Pension Fund Board. This item has been tabled to the February 2022 regular board meeting.

H. Public Education/Community Outreach

- 1. Prevention volunteer hours summary.
 - a. The summary of prevention hours for volunteers was presented for December 2021. The total number of volunteer hours was 96.
- 2. Community relations program report.
 - a. The report for Community Outreach program was given for December 2021. There was a total of 101 citizens served for December. Installations of lock boxes are scheduled through January 2022.
- 3. There were no community events for the month of December 2021.
- 4. The volunteer inspection summary report was given for the month of December. There was a total of 47 inspections completed.
