## F. Resource Management

- 1. Chief Schmitz reported that Izacc Ramos, the district's new mechanic, has officially started and is excited to work on vehicles that "make a difference".
- 2. Plymovent installation has begun at FS133. Quotes to repair the administration parking lot have been requested. The new Motorola portable radios that were received from the FEMA grant are being programmed by Motorola next week.

### G. Administrative/Special Projects

- 1. Chief Burdick gave an update on the Chief Sharing agreement. He said Chief Schmitz is doing a great job and does a lot of work for the department. He had three items for the board to consider as follows: 1 Update the district's strategic plan document and include goals for the district; 2 Work with Finance Director Gabe Buldra to scrutinize the budget to find funding for up to two administrative positions; 3 Should the Board choose to cancel the fire chief sharing agreement, the district should host a fire chief selection process. Board member Wilmes added to the list that he would like to see a merger process between SCFMD and BVFMD.
- 2. The board reviewed, discussed, and considered appointments to the Sun City Fire Fighter Relief and Pension Fund Board for the District Board of Directors member position and lay member position. Tim Wilmes volunteered to fill the District Board of Directors member position. The board voted unanimously to select Mr. Wilmes for the position. As to the lay member position, the board will consider who they might want to appoint to this position

- and revisit this item at the January Board meeting. (M: Steve Arnold/S: Phil LaBarbera; Vote Aye: David Mann, Tim Wilmes, Steve Arnold, Phil LaBarbera; Nay: None)
- 3. Chief Schmitz reported that the district's staffing software has been disabled by a ransomware attack on the software developer Kronos. It will be several weeks before the staffing software will be operational.
- H. Public Education/Community Outreach
  - 1. Volunteer Inspector Robert Pope was recognized for six years of service.
  - 2. Prevention volunteer hours summary.
    - a. The summary of prevention hours for volunteers was presented for November 2021.
      The total number of volunteer hours was 125.
  - 3. Community relations program report.
    - a. The report for Community Outreach program was given for November 2021. There was a total of 101 citizens served for November. Installations of lock boxes are scheduled through December 2021.
  - 4. There was one community event for the month of November 2021.
  - 5. The volunteer inspection summary report was given for the month of November. There was a total of 79 inspections completed.
