A SCFD permit application is required for all Fire Systems (sprinkler, alarm, hood, etc) and Tenant Improvement project modification/additions.

Annual Facilities Permit (AFP)

AFP is an administrative system to simplify permitting and inspection process for qualified facilities by allowing inspectors to review plans and perform inspections without the agency securing a permit for each simple project. Qualified facilities electing to participate in the AFP program are exempt from obtaining individual permits for work related to the code when such work does not: increase the floor area, does not increase the hazard in the area concerned, does not change the floor area for different or additional equipment installation, does not constitue a change of use or occupancy, and is performed on existing builtidings associated with that facility. An AFP is not transferable, and must be renewed every 12 months by paying the renewal fee prior to the expiration date or a new initial application shall be required. (The permit is for a Calendar year and is not pro-rated) Additional hourly fees will be assessed for each project for Plan Review/Inspections as noted below. The agent shall keep a detailed record of alterations made under the AFP and shall be made available to the SCFD as required.

AFP operation: the agent shall notify SCFD prior to the start of any work under the AFP, and the Fire Code Official will determine the nature and extent of Plan Reviews and Inspections required. The fees shall be paid prior to start of work. The inspector will review the project in the field and provide an inspection report for the completion of the project.
